TCAP-Alt for Students with Disabilities TCAP-Alt is the science and social studies assessment for students with the most significant cognitive disabilities. Students are assessed in grades 3–8 for science and social studies and in grades 10 for Biology. TCAP-Alt is administrated via paper by the teacher. National Assessment of Educational Progress (NAEP) The National Assessment of Educational Progress (NAEP) is the largest nationally representative and continuing assessment of what America's students know and can do in various subject areas. Assessments are conducted periodically in mathematics, reading, science, writing, the arts, civics, economics, geography, U.S. history, and in Technology and Engineering Literacy (TEL).	NAEP assessments are administered uniformly using the same sets of test booklets across the nation. NAEP results serves as a common metric for all and selected urban districts. The The assessment stays essentially the same from year to year, with only documented changes. This permits NAEP to provide a clear picture of student academic progress over time. In even-numbered years, NAEP measures Tennessee student's academic achievement against students in other states also taking this test.	District-level and student-level results are not provided.
